**Location:** Goat/Cattle Show Arena- The Sale of Champions will take place on Thursday August 18th at 9:00 a.m. and will be followed by the Live Market Animal Exhibitor Premium Auction. When the time comes for Market Barrow Exhibitor Premium Auction there will be a short intermission/break and the auction will move to the Swine Show Arena for the conclusion of the auction.

- **ALL JUNIOR FAIR ANIMAL PROJECTS SHOWN DURING THE 2022 MIAMI COUNTY FAIR WILL BE ENTERED IN THE ONLINE ADD-ON SALE THAT BEGINS August 19, 2022. This includes breeding stock, horses and dogs.**

## **2022 Release of animal Information:**

**IF** not going through the Market Animal Exhibitor Premium Auction on Thursday August 18th, **ALL** 4-H or FFA animals will be released on Wednesday, August 17th at the close of fair (11:00 pm) -7:00 am Thursday. Those who choose to stay Thursday and those taking part in the MARKET ANIMAL EXHIBITOR PREMIUM LIVE AUCTION are required to remain on the grounds until the sale of said species is completed. ## **Poultry check in**

1. Thursday, August 11, 2022 from 4:00 p.m. to 8:00 p.m. Check-in for Fancy Poultry, Market Ducks, Market Geese, Market Tom Turkey and Market Hen Turkey. Weigh market ducks, market geese, and market turkeys (toms and hens) at the poultry barn from 4:00 p.m. to 8:00 p.m. Exhibitors are required to check-in their own poultry projects. Market Ducks, Market Geese and Market Turkeys MUST SHOW PROOF OF HATCH DATE (NPIP hatchery papers).
2. Monday, August 15, 2022 from 4:00 p.m. to 8:00 p.m. Check-in for Market Chickens. Weigh market chickens at the poultry barn from 4:00 p.m. to 8:00 p.m. Exhibitors are required to check-in their own poultry projects. Market Chickens MUST SHOW PROOF OF HATCH DATE (NPIP hatchery papers).

**\*YOU CAN NOT PEN YOUR POULTRY PROJECT UNTIL AFTER THEY HAVE BEEN CHECKED-IN.\***

## **SHOWS:**

**Saturday, August 13, 2022 at 9:00 a.m. Junior Fair Fancy Poultry Show (order will be large fowl, bantam fowl, fancy turkey, ducks, geese and will conclude with guinea)**

**Sunday, August 14, 2022 at 9:00 a.m. Market Ducks, Market Tom Turkey and Market Hen Turkey, Market Goose and Market Gander, followed by Poultry Showmanship**

**Tuesday August 16, 2022 at 9:00 a.m. Junior Fair Market Chicken Show**

Jr. Fair participants who are exhibitors at the Jr. Fair Show will be issued a payment voucher. The voucher should be redeemed at the Sr. Fair Office by Friday, August 19, 2022, at 5:00 p.m.

## **Exhibit Rules**

1. All online poultry entries (including market classes) are due on or before June 1, 2022 at the Secretary's Office at the fairgrounds. Entry forms can be completed online at [www.miamicountyohiofair.com](http://www.miamicountyohiofair.com)
2. Birds must be a junior fair project.
3. **Market Tom Turkey, Market Hen Turkey, Market Ducks, Market Goose, Market Gander and Fancy Poultry Projects must be in place by 8:00 p.m. on August 11, 2022, and remain until 6:00 p.m. on August 14, 2022. Market Chickens, as well as All other Market Grand/Reserve and Fancy Grand/Reserve Champions, must be in place by 8:00 p.m. on August 15, 2022, and remain in place according to the 2022 Release of animal guidelines above.**
4. All fancy poultry date of ownership must be by June 1 of the current year.
5. (White) Market Chickens must be hatched on or after June 19, 2022, and cared for by exhibitors from the age of 48 hours after hatching. Chickens must be hatched, and exhibitors must be in possession by July 3, 2022.
6. (Red) Market Chickens must be hatched on or after May 1, 2022, and cared for by exhibitors from the age of 48 hours after hatching. Chickens must be hatched, and exhibitors must be in possession by May 15, 2022.
7. Market Ducks (Pekin) must be hatched on or after June 19, 2022, and cared for by exhibitors from the age of 48 hours after hatching. Ducks must be hatched and exhibitors must be in possession by July 3, 2022.
8. Market Turkeys (toms and/or hens) must be hatched on or after March 20, 2022, and have been owned and cared for by exhibitors from the age of 48 hours after hatching. Turkeys must be hatched, and exhibitors must be in possession by April 3, 2022.
9. Market Geese (Embsen) must be hatched on or after May 1, 2022, and cared for by exhibitors from the age of 48 hours after hatching. Geese must be hatched, and exhibitors must be in possession by May 15, 2022.
10. ALL POULTRY MUST COMPLY WITH THE OHIO LIVESTOCK HEALTHY EXHIBITION RULES 901:1-18-05.
11. Market Chickens, Market Ducks, Market Geese and Market Turkeys must show proof of hatch date (NPIP hatchery papers).
12. Large Fowl and Bantams less than a year old must show proof of hatch date (NPIP hatchery papers).
13. **Chickens (large and bantams) one year and older must show proof of a negative test for pullorum/typhoid disease within ninety days of check-in. Turkeys one year and older must be tested by a vet at least 1 month prior to check-in.**
14. **No vet will be on premises to blood test at the time of check-in. If you need poultry blood tested, please contact your veterinarian or Poultry Chairman prior to the check-in date. IF NO PAPERS ARE SHOWN AT TIME OF CHECK-IN, EXHIBITOR ENTRY MUST LEAVE THE GROUNDS.**
15. Quality Assurance certification must be completed and record books up to date. A separate DUN form must be filled out at check-in for each PEN of market chickens, market ducks, market geese, and market turkeys.
16. Exhibitors are limited to **SIXTEEN (16) total birds** (EXCEPT MARKET CHICKENS, WHICH HAVE A MAXIMUM OF THREE (3) ENTRIES (6 BIRDS) MAXIMUM OF TWO (2) PAIR IN EITHER J-35A OR J-35B, MARKET DUCKS, WHICH CAN HAVE A MAXIMUM OF TWO (2) ENTRIES (2 BIRDS), MARKET GEESE WHICH HAVE A MAXIMUM OF ONE (1) GOOSE AND (1) GANDER, AND MARKET TURKEYS WHICH HAVE A MAXIMUM OF ONE (1) MARKET TOM, ONE (1) MARKET HEN AND TWO (2) FOR FANCY TURKEY ENTRY.
17. Market chicken pens are to be paired prior to weighing.
18. Market Chickens, Market Ducks, Market Geese, & Market Turkeys will be tagged at weigh-in.
19. Exhibitors must be present to show their animal(s).
20. Birds can only be shown in one (1) Junior Fair class.
21. Each exhibitor is responsible to keep cages clean and to feed & water their own birds. Exhibitors must clean their pen(s) prior to leaving the fairgrounds.
22. All poultry exhibitors are required to keep their birds clean and free of manure.
23. Aisles need to be kept clean and free from shavings, cages, fair boxes, etc.
24. All birds must be washed and blown dry in the designated area.
25. Showmanship competition will be held Sunday after the Market Poultry Show. Showmanship ages are as of January 1 of the current year. Exhibitors are to follow the 4-H dress code in the fair book.

26. Trophies will be awarded to champions of each of the following classes: J-33, J-34, J-35A, J-35B, J-36, J-37, J-38, J-39, J-40, J-41, J-42, and J-43. There will also be an overall fancy poultry champion trophy awarded.
27. All feeders/water containers must be hooked onto a cage and no plastic cups allowed. Two warnings will be given to the exhibitor; the third warning will forfeit all placings and will not be permitted to sell.
28. All exhibitors must help clean the barn up daily, especially during/after the poultry show.

### **Class J-33, Large Fowl**

1. Pair (cock and hen), 1 year and older
2. Pair (cockerel and pullet), less than a year
3. Hen, single bird, 1 year and older
4. Pullet, single bird, less than a year
5. Cock, single bird, 1 year and older
6. Cockerel, single bird, less than a year

### **Class J-34 Bantam**

1. Pair (cock and hen), 1 year and older
2. Pair (cock and hen), less than a year
3. Hen, single bird, 1 year and older
4. Pullet, single bird, less than a year
5. Cock, single bird, 1 year and older
6. Cockerel, single bird, less than a year

### **Class J-35A (White) Market Chickens**

Pen of meat chickens (commercial meat type) White Cornish Cross, 2 birds, same sex, and each bird not weighing less than 4 pounds or more than 7 pounds each. Birds weighing less than 4 pounds, or more than 7 pounds will be eligible for show but will not be eligible for championship class and will not be allowed to go through the sale ring.

### **Class J-35B (Red) Market Chickens**

Pen of meat chickens (commercial meat type) Red Ranger, 2 birds, same sex, and each bird not weighing less than 4 pounds or more than 7 pounds each. Birds weighing less than 4 pounds, or more than 7 pounds will be eligible for show but will not be eligible for championship class and will not be allowed to go through the sale ring.

### **Class J-36 Market Duck**

1. Market ducks (commercial meat type) (Pekin), 1 bird, either sex, and each bird not weighing less than 5 pounds, or more than 9 pounds will each. Birds weighing less than 5 pounds, or more than 9 pounds will be eligible for show but will not be eligible for championship class and will not be allowed to go through the sale ring.

### **Class J-37 Market Turkey**

1. Single tom market turkey (commercial meat type), no weight limit
2. Single hen market turkey (commercial meat type), no weight limit

### **Class J-38 Single Fancy Turkey**

1. Pair of Fancy Turkey (heritage breed), any age
2. Turkey Fancy Hen, single bird, any age
3. Turkey Fancy Tom, single bird, any age

### **Class J-39 Ducks (Fancy)**

1. Pair of ducks (drake and hen) any age
2. Duck hen, single bird, any age
3. Duck drake, single bird, any age

**Class J-40 Bantam Ducks**

1. Pair of ducks (drake and hen) any age
2. Duck hen, single bird, any age
3. Duck drake, single bird, any age

**Class J-41 Fancy Geese**

1. Pair of geese (gander/goose) any age
2. Goose Goose, single bird, any age
3. Goose Gander, single bird, any age

**Class J-42 Helmeted Guinea Fowl**

1. Pair of guineas (cock and hen) any age
2. Guinea hen, single bird, any age
3. Guinea cock, single bird, any age

**Class J-43 Market Geese**

1. Single Market "Gander" Goose (Embdn), no weight limit
2. Single Market "Goose" Goose (Embdn), no weight limit
