**Location:** Goat/Cattle Show Arena- The Sale of Champions will take place on Thursday August 18th at 9:00 a.m. and will be followed by the Live Market Animal Exhibitor Premium Auction. When the time comes for Market Barrow Exhibitor Premium Auction there will be a short intermission/break and the auction will move to the Swine Show Arena for the conclusion of the auction.

- **ALL JUNIOR FAIR ANIMAL EXHIBITORS SHOWING DURING THE 2022 MIAMI COUNTY FAIR MAY BE ENTERED IN THE ONLINE ADD-ON SALE THAT BEGINS August 19, 2022. This includes breeding stock, horses and dogs. During Online Entry creation exhibitors will need to enter the On-Line Add On found as a Department to be included.**

### **2022 Release of animal Information:**

**IF** not going through the Market Animal Exhibitor Premium Auction on Thursday August 18th, **ALL** 4-H or FFA animals will be released on Wednesday, August 17th at the close of fair (11:00 pm) -7:00 am Thursday. Those who choose to stay Thursday and those taking part in the MARKET ANIMAL EXHIBITOR PREMIUM LIVE AUCTION are required to remain on the grounds until the sale of said species is completed. ### **General Rules and Guidelines**

- ❖ All sheep must be in place by Thursday, August 11, 2022 at 10:00 p.m.
- ❖ No sheep/goat with blue scrapie tags will be permitted on the grounds.
- ❖ **FOR POSITIVE IDENTIFICATION THE STATE SCRAPIE TAG NUMBER WILL BE USED. THERE WILL NOT BE A TAG-IN PRIOR TO THE FAIR. NO DNA SAMPLE NEEDED 2021**
- ❖ A colored picture of the scrapie tag in the ear (head shot) needs to be turned in at the time of the Entry. Photos will be used for scrapie tag clarification purposes; photos must match scrapie tag number at time of fair. Failure to match may result in disqualification.
- ❖ All animals will conform to scrapie programs. All market lambs (ewes and wethers) will be required to have scrapie tags.
- ❖ All lambs are subject to inspection and drug testing. Any exhibitor having a lamb that fails inspection and/or drug testing will forfeit any prize and be banned from showing at the Miami County Fair for a period of 3 years.

- ❖ All pens are to be cleaned by exhibitors before leaving the fairgrounds.
- ❖ Jr. Fair participants who are exhibitors at the Jr. Fair Show will be issued a payment voucher. The voucher should be redeemed at the Sr. Fair Office by Friday, August 20, 2021, at 5:00 p.m.

**Champion and Reserve Champion single market lambs and pen of two lambs will receive a rosette and trophy**

### **Rules and Guidelines**

- Market lambs must have been owned and in exhibitor's care before June 1, 2021. In the event an animal loses their scrapie tag; the exhibitor must contact the sheep committee chairman within 3 days of tag loss.
- **BACK CARDS WITH LAMB TAG NUMBER TO BE WORN BY ALL MARKET LAMB EXHIBITORS.**
- Entries must be made on or before June 1, 2021.
- Online Entries can be completed through the ShoWorks portal April 1st through June 1st
- An exhibitor exhibiting in Class J-720 must have completed a Quality Assurance program that is offered.
- Animals will be shown in classes as determined by weight with enough classes to avoid an extraordinary large number of animals in any one class.
- Each exhibitor is allowed three (3) entries in the Single Market Lamb class and one (1) entry in the Pen of Two Market Lamb Class.
- An exhibitor may show a total of five (5) market lambs in the above classes. All single market lamb entries are eligible to show as a pen of two entries except for the Champion and Reserve Champion market lambs.
- Each exhibitor will be permitted to only sell one market animal through the sale ring. Market Lamb Sale will be on Thursday, August 18, 2022
- All grand champion/reserve grand champion single market lambs sold on Wednesday, August 17, 2022 will be terminal.
- Family/household animals may only be shown during the fair by one (1) family exhibitor with that entry listed.
- Pen of two entries will be designated at time of weigh in. (Prior to entering scales.)
- The Sheep Committee will assign all pens. Request number of pens needed with entries.
- Market lambs will be weighed and tagged in the Sheep Show Arena, on Friday, August 12, 2022 following the Barn meeting.
- Prior to the weighing and tagging of animals there will be a mandatory barn meeting for sheep at 7:45 a.m. on Friday, August 12, 2022 in the sheep show arena.
- Scales will be closed to market lambs five minutes after the last call is made. Exhibitors must help with weighing of their animals.
- Light lambs under 100 pounds will show. Exhibitors of underweight and/or overweight market animals are not eligible to go through the live premium auction, but those exhibitors are still included in the online add-ons.
- Market Lambs must be slick shorn within 5 days of the weigh-in.
- An exhibitor shall sell only one lamb in the Junior Livestock Sale, unless the exhibitor holds more than one (1) champion. Only the animals exhibiting in the Junior Fair Market Lamb Show will be eligible for the Junior Fair Livestock Sale.
- Sale order will be determined by a random drawing held during the ear tagging of market lambs. Lambs sold through the Junior Fair Livestock Sale become immediate property of the buyer. Buyer's

decision only to truck or pen.

- Back cards with the market lambs tag number are to be worn by all exhibitors during the show.
- Market lambs shown only in the Miami Co. Born and Raised Show are not eligible to be sold in the Junior Fair Livestock Sale.
- All market lambs must follow the USDA rules and regulations for its scrapie program. Therefore, all market lambs (ewe and wethers) are required to have an approved USDA scrapie tag.
- Falsification of information or any deliberate attempt to subrogate the above rules will be grounds for disqualification and dismissal.
- Ram lambs and/or induced cryptorchid lambs are not eligible to show in any Market Lamb classes.
- All market lambs are subject to inspection and drug testing.
- Any exhibitor having a market lamb that fails the inspection and/or drug testing will forfeit any prize and be banned from showing at the Miami County Fair for a period of three (3) years.

## **JUNIOR FAIR SHEEP BREEDING**

Monday, following Junior Fair Market Lamb Show Exhibitor Award \$3.00

### **Rules and Guidelines**

- All sheep must have been owned and in exhibitor's care by June 1, 2022.
- Online Entries can be completed through the ShoWorks portal April 1st through June 1st, 2021.
- Exhibitor may enter up to four animals per item # and show a maximum of two per item # from the entered animals.
- Exhibitors must show registration papers when called for by the sheep committee.
- Family/household animals may only be shown during the fair by one (1) family exhibitor with that entry listed. No more than one half of entered animals for an item can be Family/ household entries.
- All sheep are required to have scrapie tags. All sheep conform to the scrapie program.
- Junior Fair participants who are exhibitors at the Junior Fair shows will be issued a payment voucher. The voucher should be taken to the Sr. Fair Office by Friday at 5:00 p.m. The money will then be issued to the exhibitor.
- Vaccinations should be done in accordance with veterinarian recommendations.

### **OPEN SHEEP BREEDING SHOW**

**Sunday, August 14, 2022 at 9am**

- **Entries close Saturday, July 23, 2022 at 3 pm**
- **Online Entries can be completed through the ShoWorks portal May 1st through June 23rd 2022**
- Entry fee \$5 per head. All entry money must be paid at the Secretary's Office or by mail when entries are made.
- Exhibitors residing in Miami County and wishing to stay for the duration of the fair are welcome to do so but must clean out pens before being awarded any premium money. If so, please include on your entry forms the number of pens that will be needed. Exhibitors residing in Miami County that will be staying for the duration of the fair must park livestock trucks and trailers at the south end of the fairgrounds behind horse barn #1.
- All out of county exhibitors will show off their trailers.
- All sheep must be in place by 8am, Sunday, August 14, 2022.
- Exhibitors are to use the South Entrance off Harrison Street to bring the sheep onto and off the fairgrounds.
- All sheep will be released Sunday, one (1) hour following the show.
- Exhibitors must show registration papers when called for by the Sheep Committee or premiums will be forfeited.
- Sheep health papers, where required, must have a corresponding ear tag or tattoo number and scrapie tags.
- Vaccinations should be done in accordance with veterinarian recommendations.
- Use the area east of sheep barns for walking sheep. No sheep are permitted west of sheep barns.

The voucher should be taken to the Secretary's Office by Thursday, August 18, 2022 by 5 pm. The money will then be issued to the exhibitor. All premium money not claimed by Thursday, August 18, 2022 at 5pm will be forfeited

In-county exhibitors who are awarded premiums for the open show and are choosing to stay on the grounds, will be given payment vouchers after pens are cleaned to the satisfaction of the Sheep Committee. The vouchers should be taken to the Secretary's Office by Thursday, August 18, 2022 by 5pm. The money will then be issued to the exhibitor. All premium money not claimed by Thursday, August 18, 2022 at 5 pm will be forfeited.

Biographical Information and cloth swatch needs to be provided to the Department Chairperson by 8am on the day of the show.

Entry fee \$10. Premiums for each age division will be based on the number of entries in the appropriate Item.

Item 1 - Senior Division (Ages 16 - 19 as of January 1, 2022)

Item 2 - Intermediate Division (Ages 13 - 15 as of January 1, 2022)

Item 3 - Junior Division (Ages 9 - 12 as of January 1, 2022)

Entrants are responsible for making their own arrangements for a sheep to use. The entrants may show their own sheep or can be sponsored by a sheep exhibitor. The sheep may be any gender, must be broke to lead and shown with a show halter. The sheep should be in show condition. Any violation of this ruling will result in immediate disqualification of the contestant. The entrant's garment must be handmade of at least 50% wool. Entrants will be judged on the entrant's poise and presentation, general appearance, garment construction and the behavior and grooming of the sheep.

# **MIAMI COUNTY BORN & RAISED LAMB SHOW**

Sponsored by the Miami County Sheep Improvement Association

**Show: Tuesday, August 16, 2022 9:00a.m.**

**BREEDER:** The breeder of the market lamb must be a resident of Miami County. The breeder must be a current member of the Miami County Sheep Improvement Association and must attend a minimum of one (1) meeting prior to August 1st for that year.

**EXHIBITOR:** Participant must be an exhibitor in the Miami County Jr. Fair Market Lamb Show. Exhibitors must nominate the lamb on the Market Lamb Entry Form due June 1, 2022 if showing in the Born & Raised Market Lamb Show.

**ENTRIES:** A \$10.00 entry fee for each lamb entered must be paid and submitted by the breeder no later than the July Miami County Sheep Improvement Association meeting to the treasurer of the sheep association. An entry fee of \$5.00 will be charged to each exhibitor for each eligible market lamb at weigh in. Exhibitors are eligible to nominate up to five (5) lambs and show up to three (3) lambs in the Born and Raised Show provided they meet the eligibility requirements.

- All market lambs must be owned and in the exhibitor's care by June 1st of the current year. Extra Born and Raised market lambs must be in place by 10:00 PM on Thursday, August 11, 2022 for barn check and will weigh in at the same time as the Jr. Fair Market lamb weigh in.
- The Born & Raised Show will be run specifically off of the lambs scrapie tag. All market lambs showing in the Born and Raised Show must be weighed, tagged, and designated for the show at weigh in. Lambs will be shown by weight as determined during the market lamb weigh in on Friday morning of the Miami County Fair. All market lambs will be shown in classes as determined by each lamb's respective weight. If one exhibitor has two (2) lambs in the same weight class, the heaviest lamb may be bumped to the next higher weight class at the discretion of the executive committee.
- The Champion and Reserve Champion single Jr. Fair Market Lambs are ineligible to show in Born and Raised Show.
